## I. <u>Meeting called to order</u> at 5:07 p.m. by Leona Florek.

Roll call of all attendees; each attendee spoke his/her name.

## II. <u>Gymnasium/Classroom/Site Enhancement/Storm Water Construction Project</u> Dan Pallotta and Robert Todisco from P3 presented to the board the preliminary estimate and the scope of the estimate.

Robert Todisco presented the existing site plane, the proposed site plan rendering, site plan marked up for VE items, a list of Value Engineering (VE) items, and the Progress Drawings.

Robert first presented the Proposed site plan rendering: storm water, egress with walkway, new asphalt and parking lot painting, minor landscaping on islands, minimizing unnecessary curbing, rear driveway and bus parking lot has been removed from the scope of the base project due to cost.
