

ADDENDUM TO AGREEMENT TO PROVIDE MEALS
Between Revolution Foods, Inc. and Holyoke Community Charter School

This addendum, executed in duplicate, entered into on April 30, 2018 between the Meal Vendor, Revolution Foods, Inc., hereinafter referred to as Revolution Foods and the receiving sponsor, Holyoke Community Charter School, hereinafter referred to as Holyoke, is created for the purpose of the following:

A. Agreement Period

As allowed by Federal procurement guidelines, contracts may be renewed by mutual agreement for up to four additional one-year periods (a.k.a. Option Years) following the Base Year, with price negotiable. At time of renewal, both Revolution Foods and Holyoke shall execute an agreement addendum/amendment stating the extended agreement period.

Option Year 2: This agreement will begin on July 1, 2018 and will end June 30, 2019.

Option Year 1: Period beginning July 1, 2017 and ending June 30, 2018.

Base Year: Period beginning July 1, 2016 and ending June 30, 2017.

B. Meal Price

Revolution Foods will charge Holyoke the following prices beginning July 1, 2018. Menu patterns follow the National School Lunch Program for grades PK, K-5, 6-8, 9-12.

Option 1: Offer vs Serve Model
