Bylaws/Estatuto

❖ Chapter 71B, Section 3 of the Massachusetts General Laws.

Three Main Goals:

- ❖ Advise the district on matters that pertain to the education and safety of students with disabilities;
- ❖ Meeting with school officials; and
- ❖ Participating in the planning, development, and evaluation of the school district's special education programs. (Survey)



Bylaws/Estatuto

Mission

- advise HCCS on matters that pertain to the education and safety of students with disabilities;
- meet with school administrators to participate in the planning, development and evaluation of the school's special education programs;
- assist the school in coordinating the presentation of at least one workshop annually within the school district on the rights of students and their parents and guardians

Mission

- ❖ promote programs within the school community to encourage understanding, acceptance and inclusion of special needs children;

Membership – Executive Board

Chair

- ❖ Set the agenda for each general meeting.
- ❖ Preside at all meetings of the SPED-PAC.
- ❖ Act as liaison for other parents of students with disabilities or suspected disabilities and the Special Education Academic Coordinator.

Membership

Secretary

- ❖ Coordinate communication between all members
- ❖ Maintain a list of the voting members and a list of general members
- ❖ Coordinate the recording, filing and posting of minutes of the SPED-PAC meetings
- ❖ Collect and review all correspondence of the SPED-PAC
